**SCHEDULE OF DRAINAGE RATES, CHARGES, FEES, AND SURCHARGES**

Effective July 1, 2018

The following drainage rates, charges and fees are assessed and payable pursuant to the Hilmar County Water District Drain Ordinance (Title 6 of Hilmar County Water District Code).

**I. DRAINAGE IMPACT FEES** (See Section 6.10.005)

<u>Type of Use</u>	<u>Amount of Fee or Charge</u>	<u>Effect of Cost of Living Increases</u>
a. Single Family Residential (considered one “Equivalent Single Family Dwelling Unit”)	\$ 4,030.75*	*Plus annual adjustments for any increases in the Engineering News Record Construction Cost Index as compared to such Index for January 1, 2019.
b. All Other Uses, Including Multi-Family Residential	The greater of:  (1) \$ 4,030.75* for each “Equivalent Single Family Dwelling Unit” assigned to such property or  (2) \$20,153.75* per acre (or proportionate amount for fractions of an acre)	*Plus annual adjustments for any increases in the Engineering News Record Construction Cost Index as compared to such Index for January 1, 2019.

**II. DRAINAGE SERVICE CHARGES** (See Section 6.10.007)

**A. Base Drainage Service Charges**

<u>Type of Use</u>	<u>Amount of Fee or Charge</u>	<u>Effect of Cost of Living Increases</u>
a. Single Family Residential	\$ 4.20 for each Single Family Dwelling Unit	See B. below
b. All Other Uses	\$ 4.20 for the first “Equivalent Single Family Dwelling Unit” plus \$2.70 for each additional “Equivalent Single Family Dwelling Unit” as defined in Article VI of the Drainage Ordinance.	See B. below
c. Out of District Users	Determined by Board on case-by-case basis.	

**B. Adjustments to Base Drainage Service Charges**

Commencing July 1, 2018 the Base Drainage Service Charges set forth in A above shall be adjusted annually on the first day of July of each fiscal year by an amount equal to the percent change in the All Urban Consumers Index, U.S. City Average (ASCA), as supplied by the Bureau of Labor Statistics on the 1st day of January immediately preceding the July 1st date of adjustment, unless or until such time as new rates are set by the Board of Directors. The amount of such adjusted Base Drainage Service Charges shall be computed as follows:

$$\text{Adjusted Monthly Drainage Service Charge Rate} = \frac{\text{Current Year Consumer Price Index (USCA) Ending Scheduled Year CPI (USCA)}}{\text{Current Year Consumer Price Index (USCA) Ending Scheduled Year CPI (USCA)}} \times \text{Base Drainage Service Charge}$$
